Re-torqued engine shock mounts, re-positioned tail pipe. Repaired lower cowling exhaust pipe exit hole. Installed heat shielding as needed. Work IAW MMM and AC43.13-1B. Complied with AD 2007-02-04 by visual inspection, found type 2 damage within repairable limits. Completed repair of type 2 damage Per SB10-148, and relocated screws per SB 10-148. Fabricated and installed placards as needed for wing grounding points. Re-torqued "B" nut on right wing fuel tank. Work IAW MMM. Tightened flap motor bolts as needed. Installed new certificate holder. Found dome light bulb to be slightly corroded. Cleaned as needed. Ops check ok. Work IAW MMM. Replaced fire extinguisher with new. Removed hydraulic press switch, cleaned threads and re-installed. Leak check found ok. Removed battery from aircraft, adjusted levels as needed and put on charger. Charged battery and re-installed in aircraft. Re-positioned grommets as needed. Replaced o-rings on LT & RT fuel caps. Installed new pn: BA-7112 filter IAW Brackett air filter document I-194. Run-up, operational and leak check good. I certified that this Aircraft has been Inspected in accordance with an Annual Inspection and is approved for return to service.
